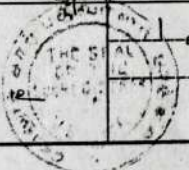

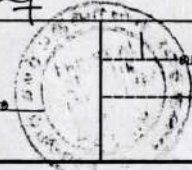

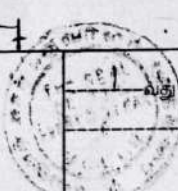

IRREVOCABLE NATURE OF THE TRUST: <sup>25/11/2005</sup> This deed of Trust is irrevocable However the founder is empowered to amend the Trust Deed in compliance with the directions of the commissioner of Income Tax Any further amendment in pursuance of any legal requirements or on the directions of any authorities shall be carried out only after obtaining the prior approval of the Commissioner of Income Tax. I. FUNDS UTILISATION CLAUSE: The Income or the Funds of the Trust shall be solely utilized towards the objects of the Trust and no portion of it shall be utilized for payment to Trustees by way of profit dividends etc and such income shall be applied for the objectives of the Trust only. J. DISSOLUTION CLAUSE: The Trust shall be dissolved, if so decided by Trustees unanimously in the General Meeting. On Dissolution of the Trust no part of the funds of the trust either movable or immovable properties shall be divided among the trustees in any form whatsoever and all such assets shall be transferred to another charitable trust or charitable society with more or less similar objectives. K. That the trust shall not carry out any activity with the intention of earning any profit except activities that are necessary connected to and in pursuance of the objectives of the trust. L. That all activities of the Trust shall be carried out within India only and the trust shall not carry out any activity outside India. M. - g. To donate to other Charitable Trusts, Educational institutions, with more or less similar objects as the Committee of the Trustees may be decided from time to time,
- h. To educate the illiterate, poor and needy weaker sections of the society through Adult Education Schemes,
- i. To donate to the Prime Ministers Relief Fund, Chief Ministers Relief Fund, of various States, and such other Fund of the Central and State Governments with the objects of providing relief for disaster and calamities of any kind,
- j. To donate, lease, or sell movable and immovable properties of the Trust to other Trusts, Societies, and Educational Institutions engaged in any charitable activity,
- k. To organize, assist and aid, to conduct continuing educational programmes in various branches of education and also aiding the deserving people to attend workshops, seminars and conferences to update their knowledge and institute awards, medals etc, in appreciation of any new inventions,
- l. To establish and run institutions, projects for tapping water sources for drinking water to rural and urban public both for drinking and irrigation, to be provided to beneficiaries at free of cost or at subsidized rates, and such facilities to be made available to all general public without any discrimination by way of caste, religion, or creed.

THE FOUNDERS HEREBY DIRECT THAT NO BENEFIT SHOULD REACH THE TRUSTEES OF THE TRUST AND THAT THE BENEFITS OF THE TRUST FUNDS, PROPERTIES AND INSTITUTIONS SHALL BE AVAILABLE TO THE GENERAL PUBLIC WITH OUT ANY DISCRIMINATION BY WAY OF CASTE, CREED AND RELIGION.

C. EXECUTIVE COMMITTEE:

From among the life time trustees, an executive committee of 14 members shall be elected once in three years. The executive committee shall consist of the following office bearers:

1. Chairman
2. Vice Chairman
3. Secretary

5. Treasurer & Nine (9) Committee members

The executive committee shall hold their office for a period of three years at a time.

The first executive committee shall consist of the following persons and as a special case they shall hold office for a term of five years.

The Executive Committee shall manage the day to day affairs of the Trust and the running of the Institutions established by the Trust.

That in case of death, resignation, or casual vacancy caused in the membership of the Committee of Trustees, the same shall be filled up by the other Trustees by cooption.

That the term of the first Executive Committee shall be for a period of five years from the date of execution of the Trust. Thereafter the Committee and the office bearers shall be elected by the general body of the Trustees from among the Trustees every once in three years.



All the powers of the Committee may be exercised by the Chairman, or by the Secretary of the Committee, which shall be got ratified by the Committee in the next meeting. The Chairman or the Secretary may delegate such powers as may be decided by the Committee to the other members of the Committee and the employees of the Trust, from time to time. The Chairman or the Secretary shall be in charge of the Minutes of Meetings, accounts, documents and correspondence relating to the Trust and its affairs.

F. MEETINGS AND NOTICES:

- a. The Executive Committee shall meet ordinarily once in 3 months and more frequently when required by the Secretary of the Committee. There shall be a clear notice of 3 days for the meeting. The secretary shall have the power to dispense with such notice and call for urgent meetings in case of necessity at his discretion. All decisions of the Committee shall be by majority vote.
- b. There shall be a quorum of 7 for the meetings of the Executive Committee and 20 for the meetings of general body of the Trustees.
- c. The General body of the Trustees shall meet once in a year to adopt the accounts of the Trust and to appoint the auditors for ensuing accounting year. The accounts of the trust shall be closed on 31<sup>st</sup> of March every year, got audited by a Chartered Accountant and be adopted by the General Body of the Trustees.
- d. The Secretary may call on his own or at the request of more than 10 members of the general body of the Trustees, an extraordinary general meeting of Trustees to discuss any other matter specially referred to in the said notice calling for such meetings. The Notice for the General Body Meetings shall also be not less than 3 days. However, in case of necessity, the Secretary may call for such meetings at shorter notice.

G. INVESTMENTS OF THE FUNDS OF THE TRUST:

The funds of the Trust, not in need of day to day requirements for the purposes of the Trust, shall be from time to time, invested or deposited:

- a) In an account opened by the Trust in any of Scheduled Banks or
- b) In any other mode of investments as specified by the provisions of Section 13(1) (d) read with Section 11(5) of the Income tax Act.1961.

The bank account of Trust shall be operated jointly by the Treasurer and the Chairman or the Treasurer and the Secretary and they are further empowered to invest or disinvest in accordance with the requirements of the Trust.

H. IRREVOCABLE NATURE OF THE TRUST:

This Deed of Trust is irrevocable. However, the founder is empowered to amend the Trust Deed in compliance with the directions of the Commissioner of Income tax. Any further amendment in pursuance of any legal requirements or on the directions of any authorities shall be carried out only after obtaining the prior approval of the Commissioner of Income tax.

I. FUNDS UTILISATION CLAUSE:

The Income or the funds of the Trust shall be solely utilized towards the objects of the Trust and no portion of it shall be utilized for payment to Trustees by way of profit, dividends, etc and such income shall be applied for the objectives of the Trust only.

J. DISSOLUTION CLAUSE:

The Trust shall be dissolved, if so decided by Trustees, unanimously in the General Meeting. On Dissolution of the Trust, no part of the funds of the trust, either movable or immovable properties shall be divided among the trustees in any form whatsoever and all such assets shall be transferred to another charitable trust or charitable society with more or less similar objectives.

K. That the trust shall not carry out any activity with the intention of earning any profit except activities that are necessary, connected to and in pursuance of the objectives of the trust.

L. That all activities of the trust shall be carried out within India only and the trust shall not carry out any activity outside India.

M. In respect of all other matters not stated elsewhere herein, the provisions regarding the charitable Trust and other Institutions of similar nature in the Indian Income tax Act shall apply.
